Foreword

Our diversity statistics as of July 2023, are outlined in this document and provided in accordance with the SRA reporting requirements.

Over the last two years, we have worked to integrate D&I into all parts of the business, built a global D&I framework and strategy, supported a growing number of employee networks, expanded the team dedicated to D&I and extended our external partnerships and commitments.

Creating and maintaining an inclusive environment doesn't happen by chance, it needs consistent effort. In addition, building a truly diverse workforce requires long term, targeted plans, to reduce opportunities for bias and ensure people from all backgrounds can thrive.

We know we have more to do and realise that data is a key part of being able to review where we are and to track our progress towards where we want to be. We will be investing in better analysis tools in order to provide us with a greater level of detail of current progress and the ability to make more specific future plans. Building on the great level of energy and enthusiasm for improving diversity and inclusion at the firm remains a key focus for us.

Notes

In line with the SRA requirements, we report on our diversity data every two years. In June 2023, we asked everyone to provide or update their diversity data as part of our campaign, in accordance with the questions and response options prescribed by the SRA questionnaire. Gathering as much accurate data is key to ensure we are able to understand the makeup of our workforce and to measure and track the progress of our D&I activities.

Figures are based on an overall completion rate of 88%.









Are your day-to-day activities limited because of a health problem or disability which has lasted, or is expected to last at least 12 months?









What type of school did you mainly attend between the ages 11-16?






Did either of your parents/guardians attend university and gain a degree (e.g., BA/BSc or equivalent) by the time you were 18?





When you were 14, which best describes the sort of work the main/highest income earner in your household did in their main job?




Are you a primary carer for a child or children under 18?




