## Sustaining our environment

*Committed to minimising the impact of our business on the environment.* 

#### Everyone's priority

Bird & Bird's international and diverse Sustainability Committee, comprising members of the Board and Executive Committee, was established to focus efforts on achieving our sustainability commitments. We have created a long-term culture of environmental awareness across the firm global wide; – our **Environmental Policy** promotes understanding of how each of us, as individuals, can make a difference, as well as developing firm wide strategic actions. Environmental management is also a priority of our Executive Committee, which receives monthly updates on our global performance.

As part of a global business, we recognise that we need to rise to the challenge of doing our part to create a sustainable environment. We acknowledge the importance of being conscious when sourcing our energy, procuring our services and handling our wastes.



#### Reducing our carbon footprint

Our approach to environmental management and performance is driven by and commensurate with the work we do as a firm. Although our main activities do not produce significant carbon emissions, we are mindful that as part of a global business, we should, as a business priority, measure, report on, and take action to improve our environmental footprint.

In an effort to reduce our carbon footprint, the Singapore office has implemented sustainable practices and measures to support this initiative. We regularly monitor energy usage and encourage staff to reduce consumption, for example, by switching off lights and electrical equipment when not in use. We also procure and use energy saving LED bulbs in the office which use approximately 75% less energy than the standard incandescent or compact fluorescent light bulbs. To help reduce wastage and encourage recycling, we have designated strategic areas in the office for recycling paper and metal.

Outside of our office, we reduce unnecessary travel and investing in technologies that enable us to productively interact virtually. When it is necessary for us to travel, we support reducing the distances travelled and increasing the use of more sustainable forms of transport and continue to increase the use of appropriate carbon compensation and offsetting tools. We also provide environmental sustainability guidance and support (including through investing in technologies) to our people when they are working remotely.



#### Partnering with organisations focused on environment sustainability through pro bono legal support and donations

We are providing legal counsel to several prominent industry associations and various registered charities in Singapore, whose work spans sustainable development, climate mitigation and other worthy causes on a Pro Bono basis. More information on these associations are listed below.

## 1. Sustainable Energy Association of Singapore (SEAS)

SEAS is a prominent non-government and nonprofit business association that represents the interests and provides a common platform for companies in Sustainable Energy sector to collaborate and undertake viable projects together. SEAS has grown steadily and runs a suite of excellent training programs for the clean energy and energy management sectors. It provides thought leadership via white papers and has a key role to play in Singapore's reputation as a global Clean Energy hub. Joint Managing Partner, Sandra Seah sits on the Board of SEAS. # Passionately providing access to justice for those who need it most

At Bird & Bird ATMD, we believe that everyone should have access to legal aid when they require it most, no matter their financial status, as helping the vulnerable and giving them a voice is what makes us human.

We have lawyers of all levels supporting this initiative by contributing their time and resources to do pro bono work under the Criminal Legal Aid Scheme (CLAS), run by the Singapore Law Society's Pro Bono Services. On average, our lawyers commit 10 to 15 hours per case.



#### Ensuring we are a force for good in the communities we operate in and the wider legal industry

Our people give their time generously to various registered charities (global and local), including:

#### 1. Read for Books 2020

We took part in the National Library Board (NLB)'s charity book drive to help raise awareness of reading and to share the gift of reading with the less privileged. From 11 to 26 July 2020, for every 10 people who read for 15 minutes, one book will be donated to selected beneficiaries. Our staff sent in photos of themselves (even their families and pets!) in the act of reading to help raise awareness and to add to the tally of "people who read". We received a letter of appreciation from the Chief Executive of NLB on 31 October 2020 commending that our participation and contributions help to raise 1,000 books for this year's beneficiary, WondeRead. The books will be delivered in WondeRead@Home customised boxes to 838 children from 16 social service agencies.

#### 2. Cycling Without Age

Cycling Without Age (CWA) is a movement started in 2012 by Ole Kassow. Ole wanted to help the elderly get back on their bicycles, but he had to find a solution to their limited mobility. The answer was a trishaw and he started offering free bike rides to the local nursing home residents. Since then, CWA has spread to 42 countries around the world. In Singapore, CWA is a registered charity that not only uses the trishaws as an intervention tool for socio-emotional well-being, but also runs other programmes to engage and empower the seniors of Singapore.
